


## Hand Turned by Jane Uhl

The next time you find a "hand turned" piece of Uhl Pottery think about the efforts of Jane Uhl to design such an object.

Jane and her assistant Robert Jefferies made these hand turned pieces.

Jane Uhl was the daughter of Charles Uhl. She had a brother Louis and a sister Helen.

When the pottery moved to Huntingburg, IN, in 1910, Jane's brother Louis was in charge of the new plant.

After studying art in Chicago, Jane Uhl returned to Huntingburg, IN, during 1925. She became a member of the board of directors in charge of the new art department.

Robert Jefferies was chose by Jane to become her personal assistant, hand turning several of the new designs produced by her. It was said that Jefferies answered to Jane Uhl only.

## His goal was to get the pottery in the hands of collectors who would enjoy it.

The Blackstone Hotel in Chicago was one of the early private exhibition locations Jane chose to promote her designs.

In 1927 Jane Uhl exhibited at the John Herron Art Institute and Art Association of Indianapolis, IN. A $\$ 30$ first place prize was awarded to her for showing 14 hand turned pieces such as tankard sets, wine sets, bean pot, cookie jars, mugs, jugs, pitchers, bottles and a cup with saucer. Most of

these items sold for $\$ 1$ to $\$ 3$ each.
During 1929 Jane was elected to the "Jury of Selection" by ballot of the exhibitors at the Indianapolis Art Institute show.

The Indiana Industrial Exposition at the Indianapolis State Fair Grounds was utilized to display her hand turned pieces in 1930.

Some Uhl Society members might remember the 1988 convention when a Birmingham, Alabama antique dealer named Ed Richman sold over 200 pieces of Jane Uhl special designed pottery.

Though information is limited, it is thought that Jane Uhl was commissioned to produce wares for a wealthy Birmingham family with the last name of Swan.

This occurred during the 1920 's and Jane traveled to England to visit
some castles to see examples of their pottery.

It is thought that the pottery was actually made in 1928.

Ed Richman sold the items he brought to the convention so fast that the buyers were unpacking the boxes for him. His goal was to get the pottery in the hands of collectors who would enjoy it and his prices reflected his wishes!

After getting married Jane Uhl left the pottery in 1931 and moved to Chicago. Later she retired to California where she died in 1965.

Her designs were ahead of their time and are a welcome addition to any Uhl Pottery Collector.
